#### Prep Time and Supervision

Be sure to check your timetable carefully to ensure you have 240 minutes of Preparation Time, in minimum 40 minute blocks (if you are 1.0 contract), and that you have no more than 80 minutes of supervision in a 5 day cycle. Any questions or concerns that there may be errors to your timetable/ supervision schedule should first be brought forward to your principal.

## **Payroll Information:**

It is EACH teacher's responsibility to ensure that their payroll information is correct. Members will be asked to repay the Board when errors occur. This can be very costly to a teacher if it is not discovered early! And the opposite can be true—you may not be paid the correct amount, and you may be losing valuable income!

Please take a few minutes to ensure that YOUR payroll information is accurate, by accessing your pay stub in the Staff Portal.

 Salary — check to ensure that your regular bi-weekly pay (as indicated on your pay stub) X 26 is what your grid salary is for September 1, 2021.

#### Please note the following:

There are two main sections on your pay stub (earnings and deductions), and two important columns in each section. The first column shows the amount for the pay period; the second is a cumulative total for the year to date (current tax year NOT the school year)
